The Academic Council also authorized the Vice-Chancellor to customize the course curriculum for the existing batches of students with the new course curriculum and credits wherever possible by offering additional seminar courses / elective courses.

The Academic Council further authorized the Vice-Chancellor to offer single / two credit courses depending on the availability of Visiting / Adjunct Faculty.

Ratification of Revised Course Curriculum and Rationalisation of Credits for 5-Year B.A., LL.B. (Hons.) Degree Programme

The Executive Council after considering the recommendations of the Academic Council approved the following:

1. Revision of Course Curriculum as given in the Agenda as Annexure – III (A) and implementation of the same for the batch admitted during the academic vear 2012 – 13;

2. Revision of Course Curriculum by the Vice-Chancellor for the remaining batches which are presently in second, third, fourth and fifth years as authorized by the Academic Council as given in Annexure – III (B) of the Agenda;

3. Allotment of one credit for 16 hours of teaching; and

4. Offering of single / two credit courses depending on the availability of visiting / adjunct faculty.

The Executive Council also approved engagement of selected final year students of 5-year B.A., LL.B. (Hons.) to conduct tutorials as part of their curricula.

RATIFICATION OF REVISED COURSE CURRICULUM AND RATIONALISATION OF CREDITS FOR 5-YEAR B.A., LL.B. (HONS.) DEGREE PROGRAMME

Recommended that the Executive Council may consider the recommendations of the Academic Council at its meeting held on
June 10, 2012 and ratify the following:

- Revised Course Curriculum as given in <u>Annexure III (A)</u> which was implemented for the batch admitted during the academic year 2012 13;
- 2. Revised Course Curriculum by the Vice-Chancellor for the remaining batches which are presently in second, third, fourth and fifth years as authorized by the Academic Council as given in Annexure III (B):
- 3. Allotment of credits to the subjects depending on the number of hours of teaching. To approve that there should be atleast 16 hours of teaching for one credit; and
- 4. Offering of single / two credit courses depending on the availability of visiting / adjunct faculty.

Explanatory Note:

The Judges Committee had made the following observations about the course curriculum:

'The course curriculum, as designed, must be reviewed periodically each year in the concerned department with the assistance, it need be, of an outside subject expert. The entire faculty of NALSAR must also be involved in such an exercise. Curriculum and performance review, in which feed back from both the faculty and the students is called for, should be introduced.'

'Introduction of a tutorial system where students, in small groups of around ten, interact with the faculty can also be introduced in the afternoon session.'

'Division of courses into mandatory and optional courses; and introducing single credit, no credit and inter-disciplinary courses; should also be examined.'

In exercise of the powers under Section 7(4) of the NALSAR University Act, 1998 the Hon'ble Chancellor advised the Vice-Chancellor to take the following action on revision of curriculum:

'A comprehensive curriculum review should be undertaken and if possible revised and improved curricula may be implemented from the academic

session 2012 – 2013. The present system of projects should be reviewed and if necessary an improved system of projects be introduced.'

'Rigorous tutorial system should be introduced and wherever possible research scholars and LL.M. students should be involved in the tutorial system.'

'The possibility of offering several single, two credit and non-credit courses may be explored.'

'Courses relevant to industry in consultation with the industry may be offered as electives.'

'Clinical courses should be reviewed and improved. Issues relevant to society like legal aid, juvenile justice issues, trafficking etc. should be introduced.'

The Executive Council at its meeting held on May 14, 2012 resolved the following:

'The Executive Council unanimously resolved to adopt all those suggestions made by Hon'ble Chancellor which do not have financial implications. In respect of suggestions which do have financial implications, the Executive Council resolved to carefully examine them and wherever feasible given NALSAR's financial situation, implement them in a phased-wise manner.

In compliance with the orders of the Hon'ble Chancellor and the decision of the Executive Council the curriculum for the 5-year B.A., LL.B.(Hons.) Degree Programme was revised from the academic year 2012-13 taking into consideration the Rules of the Bar Council of India. Four full day Faculty Meetings were conducted to discuss the revised curriculum and on the basis of the consensus evolved in the Faculty Meetings the new scheme was placed before the Academic Council at its meeting held on June 10, 2012. The Academic Council after detailed discussions and keeping in view Hon'ble Chancellor's suggestion on Judges Enquiry Report and Executive Council's decision, approved the revised course curriculum for the batch admitted in the academic year 2012 – 2013. The Academic Council also approved allotment of credits to the subjects depending on the number of hours of teaching. It was approved that there should be atleast 16 hours of teaching for one credit.

The Academic Council also authorized the Vice-Chancellor to customize the course curriculum for the existing batches of students with the new course curriculum and credits wherever possible by offering additional seminar courses / elective courses.

The Academic Council further authorized the Vice-Chancellor to offer single / two credit courses depending on the availability of Visiting / Adjunct Faculty.
