17. Multidisciplinary / interdisciplinary

Multi-disciplinarity is poised to be the guiding principle for the future of Indian higher education. Our journey toward this vision began with the establishment of a business school in 2012. NALSAR offers five full-time programs-five-year Currently, B.A., L.L.B (Hons), one-year LL.M, two-year MBA, five-year B.B.A M.B.A and Ph.D program in Law, Humanities/social sciences and business administration thereby taking the form of multidisciplinary institution. In addition to the full-time programs, the Centre for Distance and Online Education (CDOE) also offers diploma and certificate programs in online and distance mode in interdisciplinary areas for career development of professionals across sectors. The first cohort of three-year BBA students graduated alongside students of Law and MBA programs in 2024. Currently, university is fostering synergies between law and business management, and it aspires to expand into emerging fields such as law and technology, forensic science and cybersecurity, and public policy. Additionally, university aims to establish a Paralegal School to promote legal literacy, provide legal aid and services, and develop community dispute resolution skills. This initiative will address unmet legal needs and contribute to ensuring justice for all.

18.Academic bank of credits (ABC):

The University has been following Choice Based Credit System (CBCS) since AY 2012-13. Further, the University has registered for Academic Bank of Credits (ABC) and for National Academic Depository (NAD) as per the New Education Policy (NEP), 2020. It has registered its student body on the ABC portal as mandated by UGC. The University actively seeks opportunities to collaborate with both national and international institutions, fostering student and faculty exchange programs that provide exposure to diverse academic and research activities. Over the years, the University has established Memorandums of Understanding (MoUs) with many international institutions. Recently signed MoU's

include - Max Planck Institute for Legal History and Legal Theory (MPILHLT), Frankfurt, Germany and University of Bern - World Trade Institute, Bern. These MoUs facilitate numerous student exchange programs, as well as the exchange of faculty members and research scholars. Santa Clara University, U.S.A, The Reichman University (Formerly Radzyner School of Law, Israel), University of Illinois College of Law, U.S.A, University of Lucerne, Switzerland, Lewis & Clark Law School, U.S.A., EBS Law School, Germany and The Buchman School of Law, Tel Aviv University, Israel are some of the Foreign universities which have hosted NALSAR students for a semester during the academic year 2023-2024, allowing them to pursue courses that are subsequently translated into equivalent credits at NALSAR.

19.Skill development:

The University places significant emphasis on skill development across its academic programs. Law students are required to undertake essential courses such as Drafting and Conveyancing, Trial and Appellate Advocacy, Legal Methods, Moot Courts, Alternate Dispute Resolution, and courses on tax laws. Additionally, elective clinical courses are offered to further enhance their skills. Practical exposure is facilitated through programs like Legal Aid. For postgraduate law students, a mandatory course on Research Methodology is included in the curriculum. NALSAR prioritizes the development of social and communication skills by encouraging active participation in a variety of curricular and co-curricular activities, including moot courts, ADR competitions, debates, essay writing, sports, and cultural events. Similarly, the Management Department offers several mandatory skill development courses such as Business Research Methods, Introduction to R & Python, Introduction to Excel, and Introduction to Algorithms. To supplement these, zerocredit courses like Gamification, Semiotics & Branding, Taxation, and Venture Capital are provided, enhancing students' expertise. Additionally, the department includes practical simulation programs in courses like Product Management, offering hands-on learning experiences that bridge theory and practice. Lectures and panel discussions are organized by both the streams such as the Public Policy Group, Marketing Club, Finance Club, Nyaya Forum, Constitutional Law Society, Technology Law Forum, Savitribhai Phule Intersectional Studies Forum to name a few. On average, 50 invited talks from the Industry experts are hosted every academic year. To name the few activities / courses during the year 2023-2024 are- Workshop on "Skills for Practicing Law" on May 6, 2023 by Dr. Margaret Phillip, Director of Para Legal

Legal Advocates, Delhi Course on 'Security Analysis & Portfolio Management', was offered by Dr. Karuna B, Doctoral Scholar in Finance and economics from Birla Institute of Technology and Sciences. Course on 'Venture Capital and Startup Financing,' was offered by Mr. Ajay Jain is a co-founder and Managing Partner of Silverneedle Ventures. Orientation Session on 'Trading and Investment', was organized by Mr. Vishnu Bodapati, Founder Hedgeloop on August 23, 2023 Ms. Bhargavi Motukuri (Global Legal Head, S2Integrators LLC) gave an introductory talk on 'Concepts of Sustainability' on August 17, 2023. Dr. Satyanarayana Parayitam (Charlton College of Business, University of Massachusetts Dartmouth) gave a talk on 'Fundamentals of Research Paper Writing and Strategies for Publishing in Reputed SCOPUS Indexed Journals' on August 17, 2023. Mr. Anurag Agarwal delivered a guest talk on 'The Role of a Law Clerk-cum-Research Associate with the Supreme Court of India' on Sept. 29, 2023. Mr. Ashok GV (Partner, Factum Law, Bangalore) delivered a guest lecture on 'The Practice of Space Law' on October 14, 2023. This talk was directed at the students in the elective course on 'International Space Law and the Cosmic Code'. Lecture series on 'Careers in Finance', organized by nFINity Club between July -Nov, 2023.

20.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

The professional programs that the University offers are deeply invested in delivering education that is relevant to the context of South Asia in general, and the Indian polity in particular. Several specialized elective and seminar courses are offered by in-house as well as visiting faculty to showcase the significance of Indian heritage and culture, especially by encouraging students to produce research papers based on the same. Due weightage is given to sources produced in the respective Indian languages and the students are encouraged to work with translated texts and their interpretations. To give specific examples, the following courses were on offer during 2023 - 2024: Development thought and practice in India', 'Why Gandhi Still Matters?', 'Social Movements', 'Just Looking: Visual Culture in Contemporary India', 'Liberalism and its Challenges', 'Custom in India: Law, Regulation and Compliance' and 'Gender and Sexuality Studies in

India'. On the directions of the Government of India, NALSAR University of Law in collaboration with Department of Law, Ministry of Law & Justice, Government of India offered an Online Course on Indian Constitution in English and is developing it in Hindi language. NALSAR is also developing a basic course on the 'Indian Constitution in Telugu', to ensure the law is understandable by laypersons and plans offer shortly in online mode.

21. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

The programs across both streams of the University are thoughtfully designed to promote outcome-based education. Course outlines, developed by instructors, explicitly state the objectives and expected outcomes, ensuring a clear mapping of Program Outcomes (PO) to Course Outcomes (CO). This framework aligns with the guidelines of NEP 2020, enabling the tracking of student progress at various stages. The law programs not only equip students with comprehensive legal knowledge but also emphasize addressing social issues. The course structure is crafted to provide practical exposure through internships at lawyers' offices, the Supreme Court, law firms, international organizations, and national institutions. Similarly, management students are required to complete summer internships at startups, mid-sized companies, and large corporations across different regions. These internships provide invaluable hands-on experience, enhance conceptual understanding, and often lead to employment opportunities or research fellowships.

22.Distance education/online education:

The Centre for Distance & Online Education (CDOE) at NALSAR is offering five programs at Master's Level and 16 Advanced Diploma Programs for the professionals and career development of the learners in online distance learning mode. During the year 2023-2024, 1978 students enrolled in the programmes. The programs at CDOE are carefully curated and are offered in emerging areas with contemporary knowledge and skills. For example, the one-year Advanced Diploma in Criminal Law & Forensic Science imparts the candidates with the latest technological developments in this field. To facilitate this University collaborated with Truth Labs. CDOE offers two-year M.A programs in Aviation Law & Air Transport Management; Maritime Laws; Criminal Law & Forensic Science; International Taxation and Corporate Laws. CDOE also offers advanced diploma programs in patents law; media laws; cyber laws; international humanitarian law; animal protection laws; alternative dispute resolution; family dispute resolution;

drafting, negotiation & enforcement of contracts; aviation law & air transport management; maritime laws; criminal law & forensic science; financial services & legislations; GIS & remote sensing laws; corporate taxation; cyber security & data protection and Corporate Laws. The contact classes are conducted in a blended mode with the help of digital classrooms. The class rooms are equipped with smart boards, LEDs, high speed internet facility and other equipment for conducting interactive hybrid classes. Additionally, video recordings of the classes are made available to the candidates. The contact classes are conducted in a blended mode with the help of digital classrooms. The class rooms are equipped with smart boards, LEDs, high speed internet facility and other equipment for conducting interactive hybrid classes. Additionally, video recordings of the classes are made available to the candidates. The candidates are provided with web-based resources for accessing the reading materials, video recordings of the classes and other information. Further, all the examination records are integrated with E-Student Service (ESS), a web based online portal of the University. Remote access to the e-resources of the library is provided to the candidates for their research and writing. The University encourages research and continuous evaluation even in the Open and Distance Learning Programmes. Hence, the submission of research projects, case study analysis and other forms of assignments is part of the curriculum and evaluation process.

The Doctoral program of the University encourages its scholars to purse interdisciplinary research in unchartered territories. Further, the University through its Research Board and Doctoral Board encourages students to purse novel methodologies. In this regard, the University conducts various research development programs to help the doctoral students in honing their research skills. Programs across the Departments are contemporary and are designed to hone lateral thinking abilities of participants.

Teachers at NALSAR are constantly preparing numerous relevant debatable topics that can be taken up for discussion during class hours. Sessions by teachers across the departments are conducted in such a way that analytical and lateral thinking skills are honed. Interdisciplinary course structure has also aided in developing a multi-pronged approach to problem solving.

Examinations at Law department have progressed towards a model of problem solving through open book examinations where students prepare their responses to hypothetical situations than mere memorizing of statutory provisions and judicial precedents. INFRASTRUCTURE AND LEARNING RESOURCES

4.1 - Physical Facilities

4.1.1 - The institution has adequate facilities for teaching - learning. viz., classrooms, laboratories, computing equipment, etc.

The University has two academic blocks covering 34,398 sq. ft. with 18 classrooms that can seat between 30 and 80 students. These classrooms are used for lectures, tutorials, and discussions. They are equipped with modern facilities like digital podiums, LED screens, AI-powered cameras, and ceiling microphones, enabling hybrid teaching. Renovated classrooms and conference halls now allow online participation and support students with disabilities, including those who need mental health-related accommodations.

The library spans 54,323 sq. ft. and offers ample reading spaces, private carrels, and resources for students with visual and hearing impairments, such as braille printers, assistive software, and magnifiers. With access to digital resources and institutional memberships, it supports research and learning.

The Administrative Block, spread over 60,000 sq. ft., houses key offices like the Vice-Chancellor's, Registrar's, and Examination Departments, ensuring smooth administration for students and

staff.

The Legal Aid Centre, supervised by Prof. Mallikarjun Gade, involves students in providing free legal services to underprivileged communities. It partners with legal aid authorities, NGOs, and lawyers, giving students hands-on experience.

The University also has indoor and outdoor sports facilities, gyms, and separate, safe housing for male and female students.

4.1.2 - The institution has adequate facilities for cultural activities, yoga, games (indoor, outdoor) and sports. (gymnasium, yoga centre, auditorium, etc.)

The University offers a variety of facilities for cultural activities, yoga, and sports, fostering holistic development among students. A state-of-the-art auditorium, spanning 35,000 square feet and seating 800 people, serves as the center for cultural and extracurricular events. For outdoor sports, the University provides an Olympic-standard stadium with artificial turf (8,450 sq. ft.) and a large playground (87,156 sq. ft.) equipped with recreational instruments like swings and slides.

Indoor facilities include a 14,397 sq. ft. sports complex with tennis and basketball courts, badminton courts within the auditorium, and dedicated courts for basketball and table tennis in the hostels. Students also have access to separate gyms within the hostels, while faculty benefit from their own gym facility. Traditional sports are encouraged with a Kabaddi court near the dining hall and a volleyball court next to the stadium.

The University also promotes wellness through its Yoga Centre, located in the Administrative Block. This 33 ft. x 65 ft. space accommodates 100 participants and conducts regular yoga and meditation sessions.

Cultural activities are supported by a multipurpose area with a 200-person seating capacity, hosting regional festivals, annual events, and community-building activities. These diverse

facilities ensure a well-rounded and vibrant campus life.

4.1.3 - Availability of general campus facilities and overall ambience

The University provides a comprehensive range of facilities to support academic, residential, recreational, and cultural needs. The academic blocks host lectures, conferences, and discussions, while the library, enriched with both offline and online resources, includes the NALSAR Accessibility Lab for inclusive learning. Recreational facilities promote sports and cultural engagement, complementing holistic student development.

The University's residential infrastructure includes gender-specific and gender-neutral hostels accommodating 1,472 students, with single-room options for privacy. The dining hall, expanded to 27,979 sq. ft., caters inclusively, offering regional delicacies and festive menus while ensuring hygiene and fire safety.

Healthcare needs are addressed by a 24/7 Health Centre, equipped with modern medical and diagnostic tools, staffed by doctors, specialists, and nurses, and supported by preventive health programs such as vaccination and blood donation camps. Faculty and staff benefit from residential quarters, categorized into different units, ensuring comfortable living on campus.

Additional facilities include a state-of-the-art auditorium for events, a well-equipped Convention Centre, and numerous indoor and outdoor sports complexes. Legal awareness is promoted through the Nyaya Legal Aid Centre, enhancing social engagement. Cafeterias, vending machines, beauty parlors, and security services cater to day-to-day needs. Environmental sustainability is prioritized with rainwater harvesting, solar energy, and waste management systems, ensuring a holistic campus experience.

The NALSAR Data Privacy and CCTV policies address the management, security, and protection of personal data, particularly in relation to the NALSAR Forums App and email services. The Data Privacy Policy details data collection practices, permissions, and strong security measures, such as encrypted passwords and SSL certificates. It ensures compliance with privacy standards and regulates third-party plugins' data handling. The Email Policy mandates academic use and promotes security through practices like two-factor authentication. Additionally, the CCTV Policy regulates campus surveillance, with cameras monitoring only the perimeter to comply with legal standards while respecting privacy.

Implementation of these policies includes guidelines for data security and adherence to best practices, supported by tools like Jetpack and WordFence. Users must follow procedures for registering and securing their accounts.

In the fiscal year 2023-24, NALSAR allocated a budget for IT equipment such as desktops, printers, CCTV systems, and other infrastructure, totaling several lakh rupees. While some purchases are complete, others are in progress. The expansion plan for 2024-25 involves upgrading classrooms to digital spaces, expanding CCTV coverage, and enhancing network infrastructure, with an estimated budget of ?38.1 million. This plan includes desktop purchases, digital signage, and firewall renewals.

6.2 - Strategy Development and Deployment

6.2.1 - The institutional Strategic plan is effectively deployed

One successfully implemented activity based on the strategic plan at NALSAR University of Law is the Prison Legal Aid Clinic, a program focused on providing legal support to under-trial prisoners and convicts at the Central Jail in Hyderabad. The initiative includes regular visits to the prison, where students and faculty interact with inmates to identify individuals in need of legal assistance. During the last semester (June-October 2023), the team conducted six visits, engaging with 173 under-trial prisoners and 77 convicts. Through these interactions, 44 under-trials were provided with legal aid, and 13 convicts received copies of their judgments. Furthermore, 26 convicts sought legal assistance to file appeals, with Advocate Vishal taking up seven under-trial cases and four convict cases.

In addition to the in-jail visits, the program facilitated valuable conversations with judicial authorities, such as Justice Kishan Kaul and Principal District and Sessions Judge S. Sasidhar Reddy, to raise awareness about challenges prisoners face.

Moreover, students volunteered with the District Legal Services Authority to identify under-trial prisoners who were eligible for bail. Their efforts led to the successful release of 110 prisoners. Under the leadership of Dr. Murali Karnam, the clinic has made significant strides in addressing legal aid access, systemic issues, and promoting justice for prisoners.

6.5.3 - Incremental improvements made for the preceding during the year with regard to quality (in case of first cycle) Post accreditation quality initiatives(second and subsequent cycles)

In response to the NAAC team's observations and recommendations, NALSAR University of Law has implemented several quality enhancement initiatives across both academic and administrative domains during the 2023-2024 academic year.

To address the issue of faculty strength, five senior professors were recruited, including Prof. P. Srinivas Subba Rao, and Dr. Rosmy Joan contributing to strengthening the academic resources. Additionally, promotions under the Career Advancement Scheme were granted to faculty members such as Dr. Aruna B Venkat and Dr. T. Raghavender Rao. These initiatives have helped in retaining and enhancing the quality of faculty.

In terms of addressing administrative needs, the University engaged several new officers and staff members. The appointment of officers on a contractual basis, such as an Accounts Officer and Medical Officers, addressed the growing administrative demands. The recruitment of non-teaching staff, including Junior Assistants and Record Assistants, also helped streamline the operational processes.

To enhance transportation, the University requested additional bus services from the Telangana Government, and discussions are ongoing for further support. Furthermore, the University is working on the construction of staff quarters with the funds provided for campus development and is exploring the acquisition of land in the city to facilitate future campus expansion.

Additionally, the University is working on enhancing community outreach through its existing research centers.

7.1.3 - Describe the facilities in the Institution for the management of the following types of degradable and non-degradable waste (within 100 - 200 words)

NALSAR has been implementing a comprehensive waste management system. The system is based on principles of reduce, reuse and recycle. Food waste from the student mess is collected and sent to a pig farm in the nearby village of Shamirpet. Organic waste is then composted, and inorganic waste is sent for recycling. The waste water from University is stored in underground storage tank of 100,000 litres capacity. The collected water is then pumped to sewage treatment plant (STP) that uses moving bed biofilm reactor (MBBR) technology. The water that is treated is then pumped to adifferent storage tank and is finally sent for watering the plantations and gardens on campus. The residual sludge generated in the process is dried and disposed in an environmentally safe manner.

The bio-medical waste generated is segregated into four categories: yellow, red, white and blue. Each category is disposed of in different way. For effective handling of e-waste generated, NALSAR has signed an MoU with M/s Z Enviro Industries Pvt Ltd. an authorized dismantler/recycler of the State Pollution Control Board (SPCB). E-waste that is generated is collected and sent to M/s Z Enviro Industries Pvt Ltd. at regular intervals for proper disposal and recycling.

7.3 - Institutional Distinctiveness

7.3.1 - Portray the performance of the Institution in one area distinctive to its priority and thrust within 200 words

Centre for Disability Studies, NALSAR has significantly contributed to the effectiveness of the Rights of Persons with Disabilities Act 2016 and the first Country Report on Disability to the United Nations. More recently, the Centre led by Prof Amita Dhanda prepared a report on the status of the Right to Accessibility in India for the Supreme Court of India. The Report entitled "Finding Sizes for All" was accepted by the Court and has resulted in the Supreme Court asking the Government of India to redraft the Access Rules in accordance with the Act in order to clearly lay down the minimum mandatory rules of accessibility which must be followed in the built environment, transport, ICT, assistive devices, products and services. CDS is working along with the Department of Disability, Government, disabled persons and professionals to create the new mandatory rules.

Additionally, the Centre is committed to raising awareness through regular sensitisation programmes and conferences addressing crucial legal issues related to disability. These initiatives foster a collaborative environment, promoting dialogue and understanding among stakeholders, while ensuring that the voices of disabled persons remain at the forefront of all discussions.
