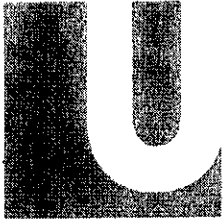

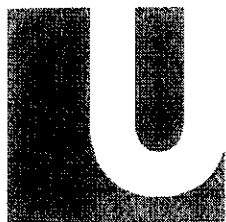

I have been accepted for a LLM at Osgoode Hall (Canada), George Washington (USA) and Lewis & Clark (USA). All three of these institutions have been kind enough to award me a fee waiver of around 50%, much like Vermont. I recognize that in my pursuit of knowledge in environmental law they all represent significant opportunities, but Vermont is the clear front runner in the field.

However, given that I have been working/earning in India and will have to pay/spend in USA/Canada, it is also an economic decision that I must make. The much lower exchange rate of the Canadian dollar and my permanent residence status in Canada make Osgoode Hall the best financial choice.

Over the last week or so I have tried to pursue other avenues to fund my education at Vermont. I have not been able to make much headway on the same, largely because all Indian scholarships/loan schemes seem to favor candidates below 30. As such, I write to you now seeking advise if there is any other scholarship(s) at Vermont for which I may apply. If further financial support is not possible, then I shall have to regretfully vacate the seat made available to me in your LLM program.



Please send us proof of such insurance prior to your visit.
7. **Housing.** It is your responsibility to arrange for housing for the duration of your visit. AirBnB operates in Tel Aviv, and there are numerous hotels. 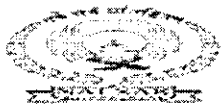
