Two day International Conference on Water Sharing in SAARC Region: Legal Issues and Challenges on March 25-26, 2017

The M K Nambyar SAARCLaw Centre, NALSAR University, Hyderabad organized two day International Conference on ‘**Water Sharing in the SAARC Region: Legal Issues and Challenges**’ on **March 25-26, 2017** at NALSAR University campus. Ambassador A N Ram, Former Secretary, Ministry of External Affairs, Government of India & Former Ambassador of India inaugurated the programme. Prof. B C Upreti, Member, Prime Minister’s Eminent Persons Group, Government of India and a very renowned South Asian scholar was the Key Note Speaker for the programme. Prof. Saligram Bhatt, Adjunct Professor, NALSAR and Prof. G S Sachdeva, Adjunct Professor, NALSAR were the Guests of Honour.

**E) Centre for Legal Philosophy and Justice Education**

**F) Centre for Constitutional Law, Policy and Good Governance  
(Centre Head: Prof. N. Vasanthi, Professor of Law)**

- Entered into an MoU with the Election Commission of India to promote collaboration in research and studies on democracy, electoral laws and election management in India and other democratic countries.

Organised a **programme on Exploring Interconnections: Indian and Irish Constitutions from September 11 to 18, 2017** funded by MHRD for an amount of Rs. 5.44 Lakhs. Justice John Mac was the Resource Person and the programme was attended by 130 participants.

The Course explored the interconnections between the Indian and Irish Constitutions. Comparative Constitutional Law is emerging as an independent area of law and practice. Most modern Constitutions, like the Indian Constitution, borrow from other Constitutions at the stage of design i.e. writing the Constitution and at the stage of its interpretation. The Indian Supreme Court has a long history of using comparative law in its judgments. It may seem unusual that any fruitful comparison could be drawn between as small a state as Ireland, and one as large as India: yet, curiously, there are significant areas where, Indians and Irish, as people, lawyers, and judges, meet our own image in law. It is, of course, a two way mirror, which reflects both ways. The overarching theme of the course is how to maintain the legitimacy of a constitution in the face of political, economic and social change, all of which impose pressures on the fabric of a constitution itself.

**G) Centre for Aerospace and Defence Laws (CADL)

**DRDO Research Project on Transfer of Technology in Indian Defence Sector**


The DRDO had assigned the research work for a comprehensive critical legal analysis on 'Transfer of Technology in Indian Defence Sector: IPR Issues and Challenges'. The work was completed and the draft report was submitted to DRDO in February, 2018. The final report after incorporating the modifications suggested by DRDO will be submitted in the month March, 2018.

**H) Centre for Tribal & Land Rights  
(Centre Head: Prof. V. Balakista Reddy, Professor of Law and Registrar)**

The Centre for Tribal and Land Rights at NALSAR has undertaken several activities which include training of Para Legals, Revenue Officers, Tribal Welfare Officers, SHG Women, Anganwadi workers and other members of the civil society organisations. The



Centre also established Legal Aid Clinic to help the poor and needy in resolving the land problems. The Centre is also creating awareness on land rights, records and procedures for getting the land problems resolved.

Nearly 112 legislations relating to the land and revenue sector were revised and the draft legislations were submitted to the State Government. The draft legislations were prepared taking into account the perspectives of various stakeholder – women, tribal, poor, landowners, land administrators and considering best land governance models. To further improve the draft legislations, number of consultations were organized at District / State Level in collaboration with Landesa on Land Administration Opportunities and Challenges. The meetings were held at the District Headquarters with an objective to discuss and understand different perspectives and aspirations of the people, and receive inputs on needed changes in existing laws. A broad range of stakeholders and experts from the Revenue Department, farmer groups, civil society organizations, women's federations, academia, and other interest groups participated in the consultations. ### Community Driven Land Records Updation

The Land Rights Centre was established with the support of Legal Services Authority at Warangal to provide free legal services to the poor on land matters. As part of the Centres initiatives, a pilot project was undertaken in eight villages of Mahabubabad, Jangaon and Suryapet District. to identify and resolve land problems. Under this project, Local Youth were selected as Community Resource Persons and Paralegals and were trained on the pilot project. They were asked to conduct door-to-door survey, collection of details from the land records, physical inspection of the land, discussion in the gram sabhas and updating of land records and resolving of land problems. In eight villages – majority of 1828 land owners had land problems. In view of this pilot project, Puttalabhupati (a tribal village) became free from land problems. Land records were updated. 73 tribal families received land records kits containing PPB, TD, Phani, IB, Proceedings copy and tippan. They have got about 22L crop loan from the bank. 50 SC families in Gopalagiri village got pattas. 60 families in Kannayapally received pattas. The community driven land records updation model was appreciated by the State Government and the Government of India.



A National Conference titled 'The Courts and the Constitution – 2018 in Review' on January 26-27, 2019 was organised under the aegis of the 'Centre for Constitutional Law, Policy and Good Governance' and 'MK Nambyar SAARCLaw Centre for Advanced Legal Studies' at NALSAR in collaboration with the School of Policy and Governance, Azim Premji University, Bangalore and the editorial team of the 'Law and Other Things' Blog. This programme consisted of eight thematic sessions with a total of 24 invited speakers drawn from the judiciary, practitioners, academics and journalists. Full details of the programme are provided under the Centre for Constitutional Law, Policy and Good Governance.

#### Two-day Law and Religion Conference

NALSAR University of Law, International Center for Law and Religion Studies, Utah, USA and South Asia Consortium for Religion and Law Studies jointly organized a two-day Law and Religion Conference from February 29, 2020 to March 1, 2020 at NALSAR.

Supreme Court of India has finally decided the long pending Ayodhya case in November, 2019. It has also referred the Sabrimala issue to the nine judges' bench which will soon hear the matter. The court is reconsidering the whole essentiality test. The Court while pronouncing its order on the Sabrimala review, has also referred the issues of Muslim women's entry in mosques, of a Parsi woman who has married outside her community's right to attend funeral ceremonies, and of Dawoodi Bohra's female genital mutilation to this bench. The conference was organized to provide an important occasion to discuss these cases and the following sub-themes:

- a) Indian courts and religious property disputes—most notably, the Ayodhya Mosque case, but very possibly others.
- b) Access to sacred sites (temples, mosques and shrines etc.). This would involve the *Sabrimala* case and other cases in which secular courts have entered rulings about who is entitled to enter (or decide upon entry) into temples or other sacred sites. The Supreme Court is indeed reviewing Sabrimala judgment.
- c) Constitutional issues raised by the national register of citizens that make citizenship and rights claims hinge (either de jure or de facto) on the religious status of those seeking registration.
- d) Anti-conversion laws and case law addressing the constitutionality of such laws. The Supreme Court recently gave four weeks to centre on the petition of Dalit Christians. They are not extended the affirmative action or reservation benefits. The Presidential Order of 1950 is a clear case of discrimination solely on the basis of religion.
- e) An issue close to the foregoing two cases is the question raised by a case decided about a year ago that overturned denial of special Indian visa status to an individual of Indian descent who had been trained in the U.S., and had then returned to India to provide medical work, on the ground that he sometimes shared his religious beliefs with patients and others.
- f) Decisions regarding prayer or other religious observances in schools. On January 24, the Kerala High Court denied religious education even in private unaided non-recognized schools. In 2019, all central



government funded schools were directed to have prayers in the schools. The matter is pending with the Supreme Court.

- g) The Triple talaq decision and other personal law issues. PILs are pending in the Supreme Court on polygamy etc.
- h) Other similar issues that raise law and religion and/or religious freedom questions.

Dr. Shilpaa Anand has been appointed as Distinguished Research Fellow at Centre for Disability Studies at NALSAR. She has a Ph.D. in Disability Studies from the University of Illinois at Chicago and an M.A. in English from the University of Hyderabad. Her research interests include literary and cultural disability studies, historiography of disability and culturally different concepts of corporeality. In her doctoral work she explored the conceptual history of disability in the Indian context.

Having worked at different universities in Hyderabad since 2009, she has previously taught courses in literary theory and criticism, cultural studies, comparative literature, nineteenth century fiction as well as American literature. Her papers have been published in edited volumes on disability studies in India and South Asia as well as in scholarly journals. She moderates a lively email list called Disability Studies India and has co-edited multiple issues on disability of the web magazine *Cafe Dissensus*.

- 'Fostering Research in Disability' - Winter School conducted by both Centre for Disability Studies and BITS – Pilani, Hyderabad campus from December 16-21, 2019

A Winter School on 'Fostering Research in Disability', the first of its kind in India, was jointly organized by the Centre for Disability Studies, NALSAR University of Law, Hyderabad and Department of Humanities and Social Sciences, BITS-Pilani Hyderabad Campus from December 16 to 21, 2019. Prof. Amita Dhanda (NALSAR) and Dr. Shilpaa Anand (BITS) served as Program Co-ordinators. The week-long Winter School engaged with questions of disability with a special focus on voice, representation and participation of disabled people in law-making and cultural processes. Thirty participants were selected out of the 130 applications received in June. Winter School attendees included research



scholars and early to mid-career faculty members from different parts of the country and abroad, researching in the fields of Humanities, Social Sciences and Law. About fifty percent of the participants were people with disability.

Resource persons included disability scholars from the disciplines of Law, Literature, Sociology, Social Work and Anthropology. Speakers appraised participants of significant developments in the field of disability research and introduced them to topics within the field which merit research such as: a) legal and cultural disability exclusions and inclusions- legally embedded and culturally enabled; discourses of *human rights* and *social justice*; c) 'voice' and 'representation' within disability studies scholarship. Few research programs in the country cater to researchers in disability studies while the application pool demonstrated that there is a steadily growing number of academics interested in the field. As a response to this situation, the Winter School on disability research has been proposed as an annual collaborative event between the two institutions.

- Co-hosted the 19<sup>th</sup> Basic Income Earth Network Congress from August 22-25, 2019 at NALSAR

The most significant activity undertaken was to co-sponsor the conclave of Basic Income Earth Network. The conclave was an opportunity for the University to reach out to scholars, activists, grassroot organizations in other parts of the country and the world to understand how the values vital to the project were being understood and executed by other individuals and organizations in other parts of the world. The project and its philosophy were shared with the delegates in a plenary panel which resulted in a number of delegates proactively reaching out to us. Thus, the strategy of proactively reaching out to likeminded scholars and activists launched in the first year of the project was further strengthened by having all the doctoral scholars attend the conclave and forge relevant scholastic connections.

Julio Linares and Gabriela Cabana-Alvear - delegates at the Basic Income Conference – presented their paper on reimagining the nature of money as currency. Their approach to alternative economics and degrowth presented us with a huge learning opportunity and has inculcated an interest in the care economy and feminist economics among some of our scholars. Prof. Phillipe Van Parijs, one of the progenitors of basic income theory, was yet another contributor at the Conference who offered critical interventions, as one who has studied the political and economic theory underlying the basic income. They served as valuable reminders that advocacy for the universal basic income is a separate project from academic and empirical research that test the basic income in social contexts other than developed economies. Indeed, the former must be grounded in ethical research carried out in social contexts in the global south as well.

In order to advance the values informing the project the next generation was exposed to the values of care and cooperation. Consequently, an intensive course on basic income was offered at NALSAR by Prof. Phillipe Van Parijs. More than hundred undergraduate and post-graduate students attended the course. In addition, all the doctoral students sponsored by the project attended the course. The induction of these values in the course curriculum has helped in drawing us closer to the above stated outcomes.

The Centre in collaboration with Tel Aviv University organized the workshop on 'Creating Conversations: From CSR Practice to Precept' during February 9-10, 2019. This workshop aimed to map and discuss available models of collaborations and legal and regulatory approaches towards Corporate Social Responsibility (CSR) that may serve as catalyst for business to target great outcomes for people and the planet too. Research Project on 'Farm Animal Protection: True Cost of Eggs Series' funded by HSI India

The animal protein production sector in India has undergone a paradigm shift in its structure and operation from being a mere backyard activity in most cases, into a major commercial agriculture-based industry over the period of four decades. In the west emerging research into the sector has shown that the environment, public health and animal welfare have suffered greatly because of industrialised animal husbandry. There is little to no research from Indian to highlight the animal welfare issues, negative externalities and public health cost associated with the rapidly growing sector. This series will shed light on some aspects of the sector by looking into the labour rights, animal welfare, public health issues associated with the egg production sector.

India ranks 3<sup>rd</sup> in the world in egg production according to Watt Executive Guide, 2015. Commercial poultry farming in India has created and still creating a profitable business opportunity for business runners. The demand for eggs in the market is never-ending but at what cost? Through this paper series you will see it is at the cost of people employed in these farms, at the cost of the environment, at the cost of the birds that supply these eggs, at the cost of the local/surrounding neighbourhood and last but not least at the cost of you! What are you consuming, where is it coming from and at what cost?



The first paper in the series will give an account of the labour rights violations in egg production facilities in and around Hyderabad. The second paper will focus on documenting the condition of birds in egg production in Telangana. The last two papers will highlight the environmental and public health issues associated with egg production because of the lack of a regulatory environment in Andhra and Telangana. Telangana and Andhra are two regions where the bulk of India's egg production happens and thus grounding the research in the region would be ideal.

This paper series aims to increase insight into the following:

- How the current system of battery cages and treating the birds as “production units” leads to immense harm not only to the birds but also to the labour and other humans in and around the poultry farms on a regular basis.
- How intensive confinement has an adverse impact on not only the animals but also causes a wide range of problems for our environment. The waste is released to our water bodies without any treatment. Our water and air quality are drastically compromised because of these industries. Studies have found that the workers of poultry farm report a more frequent occurrence of “headache, runny nose, sore throat, excessive coughing, diarrhoea, burning eyes, chest tightness.”
- The prevalence of child labour, bonded labour and other labour rights violation in the visited poultry industries.
- What are the immediate measures that the poultry industry would need to take in order to improve the working conditions and address the existent human rights violations?

### Labour Paper


- The paper has been written with insights gained from 25 field visits to egg production facilities.
- The paper is in the last stages of review and will be publication ready by 15<sup>th</sup> November.

### Animal Welfare Paper

- The paper is being drafted with insights gained from 25 field visits to egg production facilities.
- 50% of the paper has been drafted and it should be ready for publication by 30<sup>th</sup> December.

### Public Health Paper:

- Studying the Public health risks associated with egg production by building a health profile of people living in and near the facilities.
- To build a health profile of people living in zones where egg production is concentrated by partnering with public health agencies and local doctors.
- To produce a biological threat profile of egg production.

The speakers for the webinar were: Mridula Vijayraghavan who works with WCS-India as the Legal Director with a focus on wildlife law and Sumanth Bindumadhav who is the Campaign Manager for Wildlife at Humane Society International/India and has more than 20 years of experience in the field. More than 50 participants from different backgrounds participated in the webinar.

#### Research Projects

The centre is currently involved in 3 research projects:

- A project on '**Legal Personhood of Elephants in India**' in collaboration with Nonhuman Rights Project, USA.


**Description:** The main objective of the project is to file a petition for the recognition of the personhood of our client in a suitable High Court or the Supreme Court. At this stage, we are yet to decide who our client (most probably an elephant or a chimpanzee) will be and which court is most suitable for our petition. Mr. Raj Panjwani (who is a senior advocate at the Supreme Court and has been a champion of animal rights for decades) has agreed to be the lead counsel.

**Funding agency:** NhRP, USA.

**Duration:** 1.5 years approx.

**Status:** Ongoing.

- A funded project on '**Illegal Wildlife Trade and Zoonotic Diseases**' with Harvard Animal Law and Policy Program;



**Description:** One primary goal of our paper is to provide a sense of the diversity in types and cultural functions of markets, as well as the regulatory frameworks that govern them. We are selecting, as part of this process, a handful of countries to serve as “case studies” that capture this detail and allow for a deeper dive into the specifics of a particular country’s markets. We hope these case studies, when taken together, will prove the reader a sense of how animal markets may vary from one region to the next as well as what types of regulatory schemes and policies govern markets around the globe. NALSAR has signed a general MOU which includes this project and future projects that ALC & ALPP, Harvard may take up collaboratively.

**Collaborators:** This project is led by the Harvard Animal Law & Policy Program, New York University’s Center for Environmental and Animal Protection, University of Denver’s Sturm College of Law, Lewis & Clark Law School’s Center for Animal Law Studies, the University of Toronto Faculty of Law, the University of Victoria Faculty of Law, and Yale Law School’s Law, Ethics & Animals Program. It is funded by the Brooks Animal Studies Academic Network. Outside of North America, we will be working with collaborators across the world who will oversee the country-specific “case study” portion of the research. It is our hope that collaborators will share information and ideas amongst themselves, such that one of the lasting effects of this project will be a closer network of dedicated professionals working on One Health issues.

- A funded research project on ‘**Farm Animal Protection**’ in collaboration with Humane Society International, India.

**Description:** This paper series aims to increase insight into the following: How the current system of battery cages and treating the birds as —production unitsll leads to immense harm not only to the birds but also to the labour and other humans in and around the poultry farms on a regular basis. How intensive confinement has an adverse impact on not only the animals but also causes a wide range of problems for our environment. The waste is released to our water bodies without any treatment. Our water and air quality are drastically compromised because of these industries. Studies have found that the workers of poultry farm report a more frequent occurrence of —headache, runny nose, sore throat, excessive coughing, diarrhoea, burning eyes, chest tightness. The prevalence of child labour, bonded labour and other labour rights violation in the visited poultry industries. What are the immediate measures that the poultry industry would need to take in order to improve the working conditions and address the existent human rights violations?

**Status:** This year we have completed two papers: **Environment Paper:** Studying the ecological risk associated with egg production through insights gained from 20 to 30 facilities. To study sustainable models of egg production to show a way forward for the sector. To produce a chemical and carbon footprint profile for eggs in two major cities (Hyderabad and Vizag). **Public Health Paper:** Studying the Public health risks associated with egg production by building a health profile of people living in and near the facilities. To build a health profile of people living in zones where egg production is concentrated by




partnering with public health agencies and local doctors. To produce a biological threat profile of egg production.

the education in Aviation, Defence and Space Laws, and explore the current trends in these sectors. It was held on June 30, 2020.

(b) Mapping India's Defence and Security Challenges: A Way Forward

As part of "Atmanirbhar Bharat", and to push towards self-reliant India, Union Finance Minister Nirmala Sitharaman, has announced significant structural reforms in major Sectors including the Defence. An inevitable outcome of these reforms is the Private Participation in the Defence Industry. Subsequent to the hugely successful inaugural session on June 30, 2020, the 2nd Webinar of the series titled "Mapping India's Defence and Security Challenges: A Way Forward" was organized on July 7, 2020.

(c) Impact of COVID-19 on the Indian Aviation Industry

The impact of COVID-19 is for real and this unprecedented health crisis is pushing the global economy into a turmoil. The International Air transport Association estimates that the global aviation industry will lose \$252 billion in 2020. With these circumstances in mind, CADL has scheduled its 3rd Webinar in "Aerospace and Defence Law Lecture Series" titled "*Impact of COVID-19 on the Indian Aviation Industry*" on July 12, 2020, at 3:30 PM IST.

(d) Unlocking India's Private Sector Legal and Policy Challenges

With the aim to attain long-time technological, economic and industrial gains, the Indian government has opened its space sector to private players and also intends to set- up a new organisation, namely, The Indian National Space Promotion and Authorisation Centre (In-Space). In addition, the discussions on the Space Activities Bill of 2017 is still ongoing. This means that going forward we could expect an economic contribution from this sector to the GDP as these legal and policy initiatives may enable growth of the space sector activities in India. To further look into this development and get insights from the prominent persons from the Space sector, CADL has scheduled its 4th Webinar in "Aerospace and Defence Law Lecture Series" titled "*Unlocking India's Private Space Sector: Legal and Policy Challenges*" on July 19, 2020 at 3:30PM IST.

(e) Application of GIS and Remote Sensing Technologies: Trends and Prospects

This spatial component is used in various sectors including the location-based infrastructure, Disaster management, agriculture, environment assessment, health care, e-governance and many more. Research reveals that the global spatial market has an estimated value of USD 78 million, thriving at a CAGR of 16.6% during the assessment period from 2016 through 2022. With this in mind, CADL, NALSAR University of Law held webinar in "Aerospace and Defence Law Lecture Series" titled "Application of GIS and Remote Sensing Technologies: Trends and Prospects" on Saturday, 25th July 2020 at 5:00 PM IST.

(f) India as a maritime power: Contemporary perspectives

With all the contemporary issues, Our panellists in the Webinar "India as a maritime power: Contemporary perspectives", the last of the "Aerospace and Defence Laws lecture series", addressed some of them on 31st July 2020 at 5:00 PM.

### **F) Centre for Tribal and Land Rights (Centre Head : Prof. V. Balakista Reddy, Professor of Law)**

- Guided the Farmers association namely Radhakrishna Kuruma Sanghamam of Mangole Village of Kondapaka Village of Siddipet District, an extent of Ac 50.10 gts of land was acquired for Mission Bagheeratha purpose by Telangana State Government through Telangana State Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Rules, 2014 in this regard made them to aware of legal provisions and their rights with regard to the property accordingly compensation was negotiated with the appropriate officials and enhanced compensation was being awarded peacefully without any chaos and agitations.
- Gadila Lakshmi W/ o Gadila Shankariah land around 2.00 Acres of land situated at Baswapur ijara Vilage of Mulugu Mandal of Siddipet District, a poor old aged widow lady cultivating land without having proper documents in her hand, there were several disputes since last 3 years, there were many provocations and tensions by few of same villagers were tried through illegal means and force to grab the land and enjoy, but timely suggestions and legal actions made them to protect their land, on behalf of them several applications was drafted and filed before appropriate authorities to take necessary actions, still those were pursuing on time to time basis.
- New Narsimha Nagar Cooperative Society of Mallapur of Nacharam, Hyderabad it's been almost 30 years since they have been fighting for their land ownership right, as a Residential Zone from Railway Transportation Zone and thereby can help nearly 800 households, more than 5000 people in the region. While it is thoroughly noticeable that, every single owner has been paying Property Tax, Electricity & Water bills quite persistently and also paid payments towards LRS in the recent times, yet their survey number has been classified as a non-residential zone by the HMDA and their Survey numbers are not included in recently developed Dharani Portal. In this regard CTRLR given initial steps to be followed accordingly applications were drafted and helped the residents of association.
- Guided Several High Court Civil Litigation Matters to Tahsildars of Telangana State with regard to subjudice matters, Bindover cases during Election Code,



Contempt Petitions, against Tahsildars and helped them to understand the nature of litigation and grounds of facts with legal relevance.

- Centre for Tribal and Land Rights (CTLR), NALSAR University of Law, Hyderabad is continuously guiding the illiterate, poor, and needy people who approach the CTLR on their property matters, legal and litigation matters on time-to-time basis. Further drafting the legal petitions and applications to the illiterate poor people.

Expert Opinion to US on PCA

- Participated in a round table meeting with Ms. Karin King, Deputy Assistant Secretary from USA meeting held at US Consulate General, Hyderabad on February 14, 2020. The Consulate Chief Mr. Eric Alexander moderated on the discussion of Parental Child Abduction and NRI Marital Disputes.

**H. Centre for Criminal Justice Reform and Research**  
**(Centre In-Charge: Dr. Manisha Sethi, Associate Professor)**

The Centre has been newly established in 2020 with the objective to explicate the link between citizenship, rights and processes of law. It will also seek to identify systemic and structural problems within the criminal justice system, and to act as a platform for policy and reform initiatives in this regard. Some of the key areas of research at the Centre will be in the following fields:



- Special legislation, more specifically anti-terror and public detention laws
- Wrongful prosecution and convictions; evolving framework of compensation and rehabilitation
- Death penalty
- Prison studies

The Centre is intended to be home to a range of taught courses that will provide students a theoretical foundation to engage with these issues. With this in mind, two social science seminar papers were introduced: 'Emergency Jurisprudence' (Jan- April 2020) and 'Terrorism Trials' (July-November 2020).

In order to supplement these theoretical discussions with insights from the everyday world of the criminal justice system, a series of invited lectures was initiated. These included:

- '*Unlawful Activities Prevention Act and the Pathologies of Law*' by Adv. Jawahar Raja, August 11, 2020. Raja has represented terror accused, as well as defended organisations that were banned under UAPA. Raja's talk focussed on the problematic of the executive's power of proscribing organisations and its consequences for the right to freedom of speech and association.
- '*Terrorism Trials and Reflections on Fundamental Rights*' by Justice (Retd.) Abhya Thipsay, August 18, 2020. Justice Thipsay, whose landmark observations in the Kabir Kala Manch bail order have been hailed as 'transformative' and the most lucid judicial resistance to the executive tendency to abridge civil liberties in the name of exception, deconstructed UAPA and MCOCA.
- '*Guilty until Proven Innocent: A view from the Dock*' by Wahid Shaikh, August 26, 2020. Shaikh spent close to nine years in prison on terror charges and has authored 'Begunah Qaidi' (Innocent Prisoners), and has recently completed another book, *A Fair Trial?* which will take us through the nitty gritty of a MCOCA court. In his talk, Shaikh drew upon his own experience as an accused to demonstrate how all legal maxims are parodied and vitiated in a terrorism trial. His talk also indicated how, even in the face of apparent prejudicial legal process; we must also focus on what Annelise Riles has called the 'technicalities of law'.

The lecture series will be continued over the current semester.

The Centre will also serve as a repository, and the task of collecting records, reports and documents pertaining to all aspects of the functioning of the criminal justice system – produced by both governmental and non governmental sources – has already begun. The archive will be a valuable source for scholars.



**C) Centre for Animal Rights  
(Centre Coordinator, Mr. Vivek Mukherjee, Assistant Professor)**

**Research:**

- The centre signed an MoU with the Animal Law and Policy Program, Harvard Law School.
- The Centre is also undertaking Preliminary research on fish welfare and attending India's first Roundtable on Fish Welfare and Aquaculture 2021.
- The centre was represented in the team of researchers working on the South Asia case study for the Live Animal Markets Project conducted by the Harvard Law School - Animal Law and Policy Program. The project studied policy responses to live animal markets, which have been identified as sites that facilitate the transmission of zoonotic diseases such as avian influenza, Severe Acute Respiratory Syndrome (SARS), and COVID-19. It aims to provide a comprehensive assessment that will aid policy makers considering regulatory decisions, contribute to public education about these issues, and serve the human health and animal protection NGO communities.
- The legal study examining intensive animal agriculture in India from the perspective of the egg production sector has been completed. The first paper in the series titled 'True Cost of Eggs: A Cost to our Environment' is in consideration for publication.
- The Centre entered into collaboration with the Vidhi Centre for Legal Policy for their open access digital legal resource called "Nyaaya".
- The Centre contributed a chapter on Indian Animal Laws for a publication by the UK Centre for Animal Law on international animal law perspectives.
- The Centre published a short explainer blog on Zoonoses and Animal Law for World Zoonoses Day 2021.
- A paper titled 'True Cost of Eggs: A Cost to Animal Welfare' is in review for prospective publication with the UK Journal of Animal Law.
- A blog article on the Kerala High Court order declaring the unconstitutionality of ban on pets by RWAs is in review for prospective publication with the A-law Newsboard.



### **Postgraduate program in Animal Protection Laws:**

- The personal contact programmes for third batch of the Post Graduate Diploma in Animal Protection Laws for 2020-21 was successfully carried out.
- The centre collaborated with DDE, NALSAR to launch India's first MA in Animal Protection Law. The following international professors have agreed to teach for the program: Ani B. Satz, Paola Cavalieri, Gary Francione, Steven Wise, Jessica Eisen, Maneesha Deckha, Dr. Visa Kurki, Will Kymlicka and Marita Giménez-Candela.
- Semester I personal contact classes for Masters/Advanced Diploma in Animal Protection Laws were organized from 14-19 December 2021.

### **Sensitization and capacity building programs:**

- The Centre in collaboration with Bihar Judicial Academy trained 800 judges on Animal Laws.
- The Society for Non-Human Persons, NLSIU and the Animal Law Centre, NALSAR collaborated on a 10-part Animal Welfare Webinar Series held between Feb – May 2021. The following resource persons addressed the sessions: Shreya Paropkari, Sumanth Bindumadhav, Mahesh Kumar (IFS), Steven Wise, Sonia Shad, Gauri Maulekhi and Jayasimha Nuggehalli.
- The Animal Law Centre, NALSAR and NLUO held a Seminar Course on Animal Protection Laws, open to law students across India. ALC acted as knowledge partners for the same. The course was successfully completed on June 7, 2021.

### **Events:**

### **E) Centre for Tribal and Land Rights (Centre Director : Prof. V. Balakista Reddy, Professor of Law)**

NALSAR Land Rights Centre guided and helped Mr. Repalle Shiva Ramakrishnaiah S/o Repalle Nagaiah, R/O Pottimeraka Village, Repalle Mandal, Guntur District, in taking corrective steps to rectify his revenue records which were manipulated by the vendors in the revenue records against the law. The case was initially civil in nature later on turned up towards criminal as well. CTRLR patiently and promptly responded to this issue during critical covid time and advised legally and technically to rectify his land revenue records.

NALSAR Land Rights Centre also identified and guided in a case of un-approved layout of 1756 plots registered as an Enjoyer in the Revenue Records (Enjoyment Register) at thasildhar-Bhubaneswar office between 1997-2001 as Sri Laxmi Narasimha Swamy Nagar, Bhongir (ie. SLNS Nagar, Bhongir). The successor of the original pattedhars on the 154.28 acres of the SLNS through false documents became owners. Based on the said False Documents, the SLNS Nagar, Bhongir plots were sold to subsequent purchasers for several acres.



The Centre guided on the below action points

- Get prepares the CAD version of Blue print.
- Obtain tepan of said 11 number survey numbers and prepare CAD version of it.
- Mark Registered boundaries, defined boundaries information on said CAD version of drawing.
- Super impose the CAD version of Blue print over the said tepan drawing with reference to the ground position. (ie. Also match the said details with ground position).

#### **F. Centre for Criminal Justice Reform and Research (Centre Director: Dr. Manisha Sethi, Associate Professor)**

The Centre was established in 2020 with the objective to explicate the link between citizenship, rights and processes of law. It will also seek to identify systemic and structural problems within the criminal justice system, and to act as a platform for policy and reform initiatives in this regard. Some of the key areas of research at the Centre are in the following fields:

- Special legislation, more specifically anti-terror and public detention laws
- Wrongful prosecution and convictions; evolving framework of compensation and rehabilitation
- Death penalty
- Prison studies
- Extra judicial Killings

The Centre also invited Dr. Yug Mohit Chaudhury, a world renowned expert on death penalty litigation to offer a course, ‘Defending Capital Punishment Cases in India’ (July- October 2021). The course was offered from the point of view of defence lawyers, particularly those representing those on death row.

In order to supplement these theoretical discussions with insights from the everyday world of the criminal justice system, a series of invited lectures was initiated. These included:



- *'Insulting Religion, from Blasphemy to Hate Speech: The Forgotten History of Section 295A'* by **J. Barton Scott**, University of Toronto held on September 27, 2021. Prof. Scott is the author of *Spiritual Despots: Modern Hinduism and the Genealogies of Self-Rule* (Primus/ Chicago), and co-editor of *Imagining the Public in Modern South Asia* (Routledge). He is currently finishing a manuscript titled *Slandering the Sacred: Blasphemy Law and Religious Affect in Colonial India*. By exploring the nineteenth and early twentieth-century pre-history of 295A, this talk suggests that the transcolonial tale of this troubled law reveals a provocatively new history of our perpetually injured global present. Closer to a hate speech law than to a blasphemy law, 295A reveals a secularism concerned less with state neutrality or citizen rights than with the governmental management of populational affect—and, with it, populational violence.
- Symposium on **'Encounter' Killings in India was organised on October 29, 2021. The Speakers include Justice Madan B. Lokur** (Former judge, Supreme Court of India), **Justice Goda Raghuram** (Former judge, Andhra Pradesh High Court, and former Director, National Judicial Academy, Bhopal) and **Dr. Yug Mohit Chaudhry** (Advocate, Bombay High Court)

The Centre will also serve as a repository, and the task of collecting records, reports and documents pertaining to all aspects of the functioning of the criminal justice system – produced by both governmental and non governmental sources – has already begun. The archive will be a valuable source for scholars.


