### Extracts from the Patents Act, 1990

Sect 120(1A)

Infringement proceedings in respect of an innovation patent cannot be started unless the patent has been certified.

Sec 128

### Application for relief from unjustified threats

(1) Where a person, by means of circulars, advertisements or otherwise, threatens a person with infringement proceedings or other similar proceedings a person aggrieved may apply to a prescribed court, or to another court having jurisdiction to hear and determine the application, for:

- (a) a declaration that the threats are unjustifiable; and
- (b) an injunction against the continuance of the threats; and
- (c) the recovery of any damages sustained by the applicant as a result of the threats.
- (2) Subsection (1) applies whether or not the person who made the threats is entitled to, or interested in, the patent or a patent application.

Sec 129A

Threats related to an innovation patent application or innovation patent and courts power to grant relief.

Certain threats of infringement proceedings are always unjustifiable.

- (1) I
  - (a) a person:
    - (i) has applied for an innovation patent, but the application has not been determined; or
    - (ii) has an innovation patent that has not been certified; and
  - (b) the person, by means of circulars, advertisements or otherwise, threatens a person with infringement proceedings or other similar proceedings in respect of the patent applied for, or the patent, as the case may be; then, for the purposes of an application for relief under section 128 by the person threatened, the threats are unjustifiable.

Courts power to grant relief in respect of threats made by the applicant for an innovation patent or the patentee of an uncertified innovation patent

(2) If an application under section 128 for relief relates to threats made in respect of an innovation patent that has not been certified or an application for an innovation patent, the court may grant the application the relief applied for.

Courts power to grant relief in respect of threats made by the patentee of certified innovation patent

(3) If an application under section 128 for relief relates to threats made in respect of a certified innovation patent, the court may grant the applicant the relief applied for unless the respondent satisfies the court that the acts about which the threats were made infringed, or would infringe, a claim that is not shown by the applicant to be invalid.



### PROF. (DR.) V. C. VIVEKANANDAN

There are many teachers who are managing legal education today who have been part of the Faculty of the National Law School of India University, Bangalore in the initial stages of the introduction of the Five-Year Integrated LL. B. Programme in the 1980s. The initiatives they took during that period in finding new ways of teaching Law have now been acknowledged as pace setters in the reform movement in legal education in the South Asian region. A good example of this development is the Founder Dean of the School of Law at Bennett University Prof. (Dr.) V. C. Vivekanandan. A scholar in Political Science, Public Administration, Intellectual Property Rights, Internet Law and Artificial Intelligence Law, Prof. Vivekanandan held the Ministry of HRD IPR Chair for long at NALSAR University, Hyderabad and advised the Ministry on policy issues relating to IPR. He represented India in Copyright negotiations at Geneva between 2013-2015 and lectured in many countries on behalf of the World Intellectual Property Organisation. His interest in Internet Governance led him to be a member of the Internet Cooperation of Assigned Names and Numbers (ICANN), the world body managing domain names and to establish the Institute of Global Internet Governance Advocacy (GIGA) and Legal Information Institute of India at NALSAR.

Prof. Vivekanandan is now engaged in setting up a world-class law school under the Bennett University at Noida a Times of India initiative. He also serves in several committees of the Government and corporate bodies on IP Project, E-Commerce and Cyber Security. His non-law passion includes music, cinema and travel.
