





Accordingly, you are offered an appointment to the Entry Grade of the said Service on the following terms: -

- (i) The offer of appointment given to you is provisional and is subject to clearance from the Cadre Controlling Authority, i.e., Ministry of Home Affairs. In case you claim OBC Status, the Offer of Appointment is further subject to verification of your creamy layer status from the authorities concerned;
- (ii) On appointment, you will be entitled to receive pay in the Pay Level 8 [Rs.9,300-34,800 + Grade Pay Rs.4,800/- as per 6th CPC] Rs.47,600 - 1,51,100;
