17. Multidisciplinary / interdisciplinary

NALSAR offers five full-time programs-five-year B.A.,L.L.B (Hons), one-year LL.M, two-year MBA, five-year B.B.A M.B.A and Ph.D program in Law, Humanities/social sciences and business administration thereby taking the form of the form of multidisciplinary institution. In addition to the full-time programs, the Centre for Distance and Online Education (CDOE) is

offering seven Master's Degrees and 15 Advanced Diplomas in interdisciplinary areas for career development of professionals across sectors.

Since 2012-13, NALSAR has developed a vibrant CBCS in its taught programmes. In the 5-Year Integrated B.A., LL.B.(Hons.) program, students are required to complete 200 credits out of which at least 44 credits have to be earned through social sciences courses. Apart from these, law students can also choose elective and seminar courses combining the study of law and other diverse disciplines which include Psychology, information technology, philosophy, forensics. In the 5-year Integrated Program in Management, students are required to complete 310 credits out of which 53 credits have to be earned through various interdisciplinary courses in law and social sciences. In the 2-Year MBA programme, students are required to complete 130 credits out of which around 17 credits have to be earned through such courses.

University also offers clinical programmes like Legal Aid and Awareness Clinic, Animal Law Clinic, Prison Legal Education Clinic, Family Law Clinic through which students are connected with community. NALSAR students of Prison Legal Education Clinic volunteered with the District Legal Services Authority to identify eligible under-trial prisoners across 16 courts who qualified for bail according to a 21-point criteria outlined by the Supreme Court. Through their efforts, they identified 120 prisoners, whose trial periods and sentences were taken into consideration for a set-off. As a result, 110 prisoners were successfully released, marking a significant achievement in their quest for justice for prisoners.

The five-year B.B.A M.B.A program also offers exit in the third year and fourth year of the program, thereby providing flexibility to its participants. On the completion of the third year of program, the students continue with the post-graduation program. This five-year program is in addition to the two-year MBA program that the Department of Management Studies offers. Further, the CDOE also gives an entry and exit option for all its MA programs offered in ODL mode. Hence, the University facilitates multiple entry and exits.

The University engages in many multidisciplinary and socially relevant research projects. Some of the research projects during the reported period include the rights of women in the film industry, A socio-Legal study of Access to Equal Educational

Opportunities, Functioning and Impact of Open Prisons on Rehabilitation of Prisoners, etc.

18.Academic bank of credits (ABC):

The University has been following Choice Based Credit System (CBCS) since AY 2012-13. Further, the University has registered for Academic Bank of Credits (ABC) and for National Academic Depository (NAD) as per the New Education Policy (NEP), 2020. It is in the process of registering its student body on the ABC portal. University.

The University continuously explores all avenues to collaborate with national and international institutions for student and faculty exchange programmes to expose them to varied academic and research activities. The University has over the years entered into Memorandums of Understanding (MOUs) with 33 international institutions. These MoUs continue to support several student exchange programs and also support exchange of faculty members and research scholars. Several foreign universities have hosted students from NALSAR for a semester to pursue courses with them. The academic performance at these universities is translated into equivalent credits at NALSAR.

The University is in correspondence with several foreign universities to sign new MoU's which contemplate student exchange, research collaborations and jointly taught courses in area such as Intellectual property, International Law and Legal History.

The faculty design their own curriculum which is discussed at CDC (Curriculum Development Committee) meetings held regularly. The best practice of the University regarding curriculum development is to ensure that all the faculty members make their presentations before their colleagues and consider the views and suggestions given by them and incorporate the same in the curriculum.

19.Skill development:

The University has been placing a lot of emphasis on the skill development of its students across the programs. Law students of the University are taught certain mandatory courses such as "Drafting and Conveyancing", "Trial and Appellate Advocacy", "Legal Methods", "Moot Courts" and "Alternate Dispute Resolution" and courses on tax laws. Additionally, the University also offers elective clinical courses aimed at developing the skills of the

students. Further, the University also facilitates programs such as 'Legal Aid' to provide practical exposure to students. The Post Graduate law program offers a mandatory course on "Research Methodology".

NALSAR places a special emphasis on the development of social and communication skills by encouraging students to participate in, as well as organize, a wide range of curricular and co-curricular activities such as moot courts, ADR competitions, competitive debates, essay writing, sports and cultural activities.

The students of the Management Department are also offered several skill development mandatory courses such as "Business Research Methods", "Introduction to R & Python", "Introduction to Excel", "Introduction to Algorithms" to name a few. In addition to the mandatory courses, DoMS also offers several zero credit courses to add to the skill development of the students. The zero credit courses include "Gamification", "Semiotics & Branding", "Taxation", "Venture Capital" etc. In addition to these courses, the Management Department also offers simulation programs in courses such as "Product Management" etc. which add to the learning of the students in the most practical way. The students of the Management Department are also exposed to various club and cell activities through which the students learn the concepts of Marketing, Finance, Operations, Equity Trading etc. In addition to technical courses, the Department also offers foreign language courses such as French, German etc. to its students. The University engages industry resource persons to render elective courses, guest lectures, conferences and seminars to impart practical skills to the students. CDOE of the University also offers skill based courses like One-Year Advanced Diploma in Criminal Law & Forensic Science and One Year Advanced Diploma in Cyber Security & Data Protection Laws.

The University also focuses on the development of social and communication skills by encouraging students of both the law and management streams to participate, as well as organize, a wide range of curricular and co-curricular activities such as moot courts, case study competitions, B-plan competitions, ADR competitions, debates, elocutions, essay writing competitions, sports competitions etc. The University also encourages students to learn yoga and participate in cultural activities.

Lectures and panel discussions are organized by both the streams such as the Public Policy Group, Marketing Club, Finance Club, Nyaya Forum, Constitutional Law Society, Technology Law Forum,

Savitribhai Phule Intersectional Studies Forum to name a few. On average, 50 invited talks from the Industry experts are hosted every academic year.

20.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

The professional programs that the University offers are deeply invested in delivering education that is relevant to the context of South Asia in general, and the Indian polity in particular. Several specialized elective and seminar courses are offered by in-house as well as visiting faculty to showcase the significance of Indian heritage and culture, especially by encouraging students to produce research papers based on the same. Due weightage is given to sources produced in the respective Indian languages and the students are encouraged to work with translated texts and their interpretations. To give specific examples, the following courses were on offer during 2022 - 2023: 'Discourses (and Counter Discourses) Disadvantaging Bi/Multilinguality'; 'Religion and Secular Theologies'; 'New and Old Peasant Movements in India: A comparison'; 'Relevance and Relativism: Interpreting Early India'; 'Approaching Nationalisms: Origins & Forms'; 'The Law & the Informal City'; 'The Roads Not Taken: Alternative Imaginaries of Constitution-Making'.

On the directions of the Government of India, NALSAR University of Law in collaboration with Department of Law, Ministry of Law & Justice, Government of India offered an Online Course on Indian Constitution.

21. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

The programs of both the streams of the University are designed to facilitate outcome-based education. The course outlines developed by the course instructors explicitly mention the course objectives and course outcomes. This ensures effective mapping of PO - CO and the progress of students can be tracked at various stages as set by NEP, 2020. The law programs of the University not only provide sound legal knowledge to students, but also focus on social issues. The course structure of the law program is designed in such a way that the student gets to intern at lawyer's offices, in the supreme court, law firms, international bodies as well as national organizations. The management students are also mandated to intern every summer at start-ups, mid-size corporates and large corporates across geographies. These internships offer rich experience to the students and aid their conceptual understanding. Many of these internships lead to

22.Distance education/online education:

The Centre for Distance & Online Education (CDOE) at NALSAR is offering seven programs at Master's Level and 15 Advanced Diploma Programs for the professionals and career development of the learners in online distance learning mode. The programs at CDOE are carefully curated and are offered in emerging areas with contemporary knowledge and skills. For example, the one-year Advanced Diploma in Criminal Law & Forensic Science imparts the candidates with the latest technological developments in this field. To facilitate this University collaborated with Truth Labs. CDOE offers two-year M.A programs in Aviation Law & Air Transport Management; Security & Defence Laws; Space & Telecommunications Laws; Maritime Laws; Criminal Law & Forensic Science; International Taxation and Animal Laws. CDOE also offers advanced diploma programs in patents law; media laws; cyber laws; international humanitarian law; animal protection laws; alternative dispute resolution; family dispute resolution; drafting, negotiation & enforcement of contracts; aviation law & air transport management; maritime laws; criminal law & forensic science; financial services & legislations; GIS & remote sensing laws; corporate taxation and cyber security & data protection.

The contact classes are conducted in a blended mode with the help of digital classrooms. The class rooms are equipped with smart boards, LEDs, high speed internet facility and other equipment for conducting interactive hybrid classes. Additionally, video recordings of the classes are made available to the candidates.

The candidates are provided with web-based resources for accessing the reading materials, video recordings of the classes and other information. Further, all the examination records are integrated with E-Student Service (ESS), a web based online portal of the University. Remote access to the e-resources of the library is provided to the candidates for their research and writing. The University encourages research and continuous evaluation even in the Open and Distance Learning Programmes. Hence, the submission of research projects, case study analysis and other forms of assignments is part of the curriculum and evaluation process.

2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problemsolving methodologies are used for enhancing learning experiences

Teachers at NALSAR equip themselves with numerous debatable questions that can be posed to students during class hours. Classes are in such a way that skills of analysis, critical thinking and multi-pronged thinking of students are nurtured systematically. Interdisciplinary approach to course structure has also aided in solving real-world situations. Teachers encourage students to have interdisciplinary thinking and discussions to legal and management problems of real world.

Examination pattern at law department has progressed towards a model of problem solving through open book examinations where students prepare their response to hypothetical situations than simply memorizing statutory provisions and judicial precedents. Students are required to present their assignment before faculty and students to ignite mutual discussion and fellowship. In elective and seminar courses, evaluation criterion generally includes group discussions, response papers and group assignments, which require students to work collaboratively. Management department has embedded case study approach in its evaluation scheme across all courses. It also subscribed to simulation games for courses like product management, marketing management, design thinking etc. to facilitate practical honing of skills. Students are encouraged to take up real-time projects to gain first-hand experience. University's tutorial system focuses on peer learning, where senior students tutor junior students.

The University regularly recruits faculty members to permanent positions as per the regulations of UGC. Further, the University also recruits faculty members on contractual appointments to accommodate the needs and requirements of the University. In order to encourage the younger faculty members to complete their Ph.D, the University provides non-teaching semesters on a case-by-case basis. The course allocation is also done in such a way that younger faculty members can offer elective or seminar courses pertinent to their research interests. Faculty members interested in pursuing research projects or academic assignments are also given leave.

The University also has a faculty incentive scheme that monetarily incentivizes faculty members for publishing papers in scopus indexed journals. In addition to research articles, the University also incentivizes faculty members for publishing books in leading

Since its inception, the University has been following a continuous evaluation system. Across the Departments, the University offers various mandatory and elective courses. The internal assessment methods include different kinds of assignments such as book reviews, term papers, structured interviews, project report submissions, legislative analysis, policy analysis and research papers. Turnitin is extensively used by the examination cell of the University for both the Departments. The University developed ESS examination system portal, which is used for the conduct of examinations and processing of results. The scores of all the candidates for each course is recorded in this database and are published to the students at the end of each semester. Further, all precautionary measures are taken to ensure confidentiality. The ESS system is also used for the enrollment of students in the respective electives, seminars and clinical courses.

As part of its strategic plan, NALSAR University of Law has successfully implemented a collaboration with the Sardar Vallabhai Patel National Police Academy (SVPNPA). Through a Memorandum of Understanding (MoU), NALSAR and SVPNPA established a joint initiative to offer a Master's Program in Criminal Justice Management for Indian Police Service (IPS) probationers and a Postgraduate Diploma course for officers from foreign countries undergoing training at SVPNPA. The Master's Program spans two years for IPS Officer Trainees, while the PG Diploma program extends for one year for foreign officers during their Basic Course Training at SVPNPA. The curriculum mandates attendance at all SVPNPA sessions and completion of program requirements set by both SVPNPA and NALSAR. A collaborative committee comprising representatives from NALSAR and SVPNPA oversees program activities, including teaching, question paper setting, evaluation, and dissertation supervision. The academic structure allocates credits based on teaching hours and practical training undertaken by probationers during their training phases. This initiative exemplifies NALSAR's commitment to strategic planning by fostering partnerships with prestigious institutions and enhancing educational offerings in specialized areas like criminal justice management.

7.1.3 - Describe the facilities in the Institution for the management of the following types of degradable and non-degradable waste (within 100 - 200 words)

NALSAR has been implementing a comprehensive waste management system. The system is based on principles of reduce, reuse and recycle. Food waste from the student mess is collected and sent to a pig farm in the nearby village of Shamirpet. Organic waste is then composted, and inorganic waste is sent for recycling. The waste water from University is stored in underground storage tank of 100,000 litres capacity. The collected water is then pumped to sewage treatment plant (STP) that uses moving bed biofilm reactor (MBBR) technology. The water that is treated is then pumped to a different storage tank and is finally sent for watering the plantations and gardens on campus. The residual sludge generated in the process is dried and disposed in an environmentally safe manner.

The bio-medical waste generated is segregated into four categories: yellow, red, white and blue. Each category is disposed of in different way.

For effective handling of e-waste generated, NALSAR has signed an MoU with M/s Z Enviro Industries Pvt Ltd. an authorized dismantler/recycler of the State Pollution Control Board (SPCB). e-waste that is generated is collected and sent to M/s Z Enviro Industries Pvt Ltd. at regular intervals for proper disposal and recycling.

First Best Practice:

- 1. Title of the Practice: Interdisciplinary Academic Offerings
- 2. Objectives of the Practice: Legal and Management studies are not distinct from politics, economy and society. Keeping this in view, NALSAR has always focused on integrating disciplines while designing courses of its various programs.
- 3. The Context: NALSAR introduced the Choice Based Credit System in 2012-13 and since then the University has seen an increase in the number of credits to be earned by a student for the award of BA LLB(Hons) degree. The University specifically saw an increase of 20 credits for the award of the degree and out of this, 9 credits were allocated to social science seminars. This mandatory enhancement of social science courses helped in strengthening the interdisciplinary learning of the students.
- 4. The Practice: To achieve the stated objective NALSAR has been recruiting faculty members from diverse disciplines such as History, Political Science, Sociology, Economics and English. In addition to this, NALSAR has been inviting visiting faculty members for rendering various topical courses.
- 5. Evidence of Success: The fact that the students were getting the benefit of a wide range of interdisciplinary mandatory and elective courses has produced results in terms of more

To bolster the argument, NALSAR offers courses like 'Enterprise Resource Planning', 'Digital Evidence Retrieval and Analysis Systems', 'PAT Informatics' etc. to law students which has aided the above-stated multi-pronged thinking.

In addition to Law students, Management students have been sensitized on society, politics and economy because of peer-to-peer interactions of management and law Departments. This shade of legal and ethical thinking is a very unique characteristic of today's management students.
