#### **About The Square Circle Clinic:**

The Square Circle Clinic is a criminal justice initiative at NALSAR University of Law, with its offices in New Delhi, Pune, Nagpur and Hyderabad. The Square Circle Clinic undertakes *pro bono criminal defense of prisoners sentenced to death and also undertrials*, research and public engagement efforts on issues relating to the death penalty, forensics, criminalisation and punishment, prevention of torture, legal aid, and mental health and criminal justice. The staff, including the leadership, at The Square Circle Clinic earlier carried on the abovementioned criminal justice work as Project 39A and moved to NALSAR in April 2025. In a decade, Project 39A produced a breadth of empirical and doctrinal research on various aspects of the criminal justice system.

#### **Responsibilities:**

- A. Developing The Square Circle Clinic's website visual design, technical development and final delivery.
- B. Build the information architecture and frameworks for our content (including reports, impact, static content, and interactive public dashboards built on The Square Circle Clinic's data)
- C. Implement the website developed through The Square Circle Clinic's chosen domains.
- D. Create and deliver a plan for launching the website.
- E. Provide maintenance support and troubleshoot guidance for an agreed upon period of time after the website release.
- F. Produce structures for analytics and insights of the website to The Square Circle Clinic.
- G. Undertake training for The Square Circle Clinic's staff on how to manage and continue updating the final website.
- H. Design, develop, and deliver the website within 3 months of the contract being issued.

#### Qualifications and Requirements:

- A. Relevant work experience in visual design and web development related fields of a minimum of 4 years is required.
- B. Professional recognition and awards will be an advantage.
- C. English proficiency is preferable.
