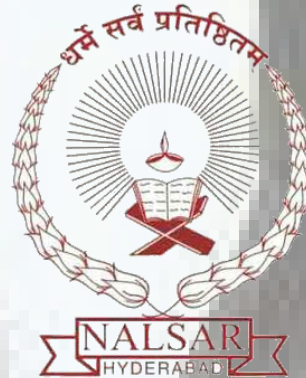

Created in 1950, the organisation works to ensure that everybody has the right to seek asylum and find safe refuge, having fled violence, persecution, war or disaster at home. During times of displacement, UNHCR provides critical emergency assistance in the form of clean water, sanitation and healthcare, as well as shelter, blankets, household goods and sometimes food.
