1. INTRODUCTION

This Annual Report on the working of the University has been prepared by the Executive Council for presentation to the General Council in pursuance of the requirement under Section 12(2)(iii)(a) of the NALSAR University Act, 1998. The period covered is the calendar year **from January 1, 2013 to December 31, 2013.**

2. CHANCELLORS OF THE UNIVERSITY

Hon'ble Shri Justice Pinaki Chandra Ghose, Chief Justice of Andhra Pradesh High Court was Chancellor from June 25, 2012 to March 7, 2013.

Hon'ble Shri Justice V. Eswaraiah, Acting Chief Justice of Andhra Pradesh High Court was the Acting Chancellor from March 8, 2013 to March 9, 2013.

Hon'ble Shri Justice N.V. Ramana, Acting Chief Justice of Andhra Pradesh High Court was the Acting Chancellor from March 10, 2013 to May 20, 2013.

Hon'ble Shri Justice Kalyan Jyoti Sengupta, Chief Justice of Andhra Pradesh High Court is at present the Chancellor of the University w.e.f. May 21, 2013.

3. GENERAL ADMINISTRATION

NALSAR has been **ranked as the number one Law School** by India Today – Nielsen Survey in 2013. In 2012, Outlook had ranked NALSAR as number one Law School of the Country.

Faculty Meetings	Weekly Faculty Meetings were held on all Wednesdays after the Faculty Seminar.

As per the directions of the Hon'ble Chancellor, detailed **Financial Regulations** including the purchase procedures and tendering system were prepared and the same were approved by the Executive Council.

The Hon'ble Chancellor also directed that the University should prepare the detailed **Service Regulations** detailing job responsibilities of all University Officers including Leave Rules, Faculty Recruitment and composition of Selection Committee etc. The Service Regulations including the procedure for appointment, composition of selection committees, qualifications, pay scales, duties & responsibilities, leaves, conduct and other service matters pertaining to the Vice-Chancellor, Registrar, Faculty and other non-teaching staff were prepared and the same were approved by the Executive Council.

The University established the Counselling Centre to reduce stress amongst the students. Dr. Diana Monteiro who has Ph.D. in Counselling Psychology from the University of Southern Mississippi, U.S.A. and worked as psychologist in Tennessee, U.S.A. was appointed as full-time Counsellor to look after the Counselling Centre.

The University also established a Restorative Justice Centre. Prof. Martin E. Price, U.S.A. is teaching Restorative Justice and is taking care of the Centre. As per Hon'ble A.P. High Court's Order on PIL 106 of 2013, Dr. Martin E. Price was requested to head the NALSAR Restorative Centre and provide assistance to other universities in the State of Andhra Pradesh in establishing restorative justice disciplinary proceedings. **The Hon'ble High Court had appointed Prof. Faizan Mustafa as the Chairman of the Committee of Vice-Chancellors to suggest measures in reducing student stress which leads to commission of suicides on University Campuses. All the recommendations of Prof. Faizan Mustafa Committee were subsequently accepted by the Hon'ble High Court.**

Registrar

Prof. K.V.S. Sarma, Professor of Law officiated as the Registrar w.e.f. **March 20, 2012 till February 26, 2013** in addition to his duties as Professor.

5. ACADEMIC PROGRAMMES

5-Year B.A., LL.B. (Hons.) Degree Programme

Admissions (2013-2014):

During the year under report, admissions for the sixteenth batch of under graduate course were made through **Common Law Admission Test-2013** conducted by Hidayatullah National Law University, Raipur where 27627 candidates took the test on May 12, 2013. **80 students were admitted to the B.A., LL.B. (Hons.)** degree programme including 45 Girls. Among the admitted students four students from Nepal, one student from Spain and five students from U.S.A. were admitted under the Foreign Nationals category. The remaining 70 students admitted to the course were from 15 different States in the Country. The academic session started on July 1, 2013.

Revamping of Clinical Courses

NALSAR was offering four mandatory courses in Clinics (Clinic I, II, III and IV) of six credits each since its inception till the academic year 2012–2013. Clinic courses were not well designed yet they made a huge difference to students overall performance in terms of their CGPA as the courses were of six credits each. Clinic courses should be completely practical, i.e., 'learn while doing'; however University could not offer them as such in view of the constraints: such as distance, language, time, work availability etc. Hence, courses were handled in a classroom through lecture method except few outreach

programs designed under legal aid, trial and appellate advocacy training, court proceedings observation.

NALSAR redesigned clinical courses as part of academic revamping from the academic year 2013 - 2014. Clinical courses commence from the third year hence the new scheme could be made available to students admitted in the academic year 2010 – 11 and subsequently. Students admitted for B.A., L.L.B. (Hons.) are now required to complete 16 credits in clinical courses. Clinic courses are now completely practical oriented. Students are given the option to choose the programs designed under clinics and complete the requisite 16 credits within their five year period. University has designed mandatory and optional clinical programs where teachers are floating a clinic which indicates the requisite work they expect from the students accordingly students shall exercise their option to join the clinic if the work suits their interest. Student's enrollment in each clinic is restricted to twenty students in number. Each clinic generally has more than one teacher supervising the students work under the clinic. University presently has four clinics, i.e., 1) Legal Aid and Social Justice Clinic; 2) Land Laws Clinic; 3) Arbitration and Ethics Clinic; and 4) Family Law Clinic. Out of these four Clinics only Arbitration and Ethics Clinic is mandatory as these courses are mandatory subjects as per Bar Council of India Regulations. Each clinic has distinct outreach programs and different work assignment requirements. Within each clinic the student shall decide in consultation with teacher in charge which assignment he/she may opt for the semester. University is making efforts to establish more clinics and individual clinical programs to enhance the options to the students and develop sustainable vibrant clinical programs.

Examinations (2008-2013 Batch)

End-Semester examinations for the B.A., LL.B. (Hons.) (2008 - 2013 Batch) were held in the last week of April, 2013. Where **80 students were appeared for the end-Semester examinations and all of them passed** the said examinations. The B.A., LL.B. (Hons.) Degrees were awarded to the successful students at the Annual Convocation held on July 27, 2013.

One Year LL.M. Degree Programme

In view the guideline of the University Grants Commission, one year LL.M. programme with six specialisations was introduced in the year under report. NALSAR was the first university in India which had decided to introduce one year LL.M. The specialisations offered include : Corporate & Commercial Laws; International Trade Law; Intellectual Property Laws; Personal Laws; Legal Pedagogy and Research and General LL.M.

Admissions (2013-2014)

Admissions for the twelfth batch (first batch of the one year LL.M. program) of the LL.M. Degree Programme were made during the year under report through **Common Law Admission Test–2013** conducted by Hidayatullah National Law University, Raipur where 1242 candidates took the test on May 12, 2013. **60 students were admitted** at NALSAR including 38 Girls. The students admitted were from as many as 17 States all over the country.

Examinations (2011-2013 Batch)

The students who were admitted to 2-Year LL.M. Programme in 2011 had submitted their Dissertations in the month of April, 2013. In all **Fifty three candidates submitted their Dissertations and all of them qualified** for the award of LL.M. Degree. The LL.M. Degrees were awarded to the successful students at the Annual Convocation held on July 27, 2013.

2-Year Master's Degree in Law of Financial Services and Capital Markets

The course was discontinued by the university.

Examinations (2011-2013 Batch)

The examinations for students admitted to 2-Year ML (FS&CM) in 2011 were conducted in the month of May, 2013. Where **twenty two students appeared out of which nineteen students were declared qualified** for the award of the Degree. The 2-Year ML (FS&CM) Degrees were awarded to the successful students at the Annual Convocation held on July 27, 2013.

2-Year Master's Degree in Business Administration (Business Regulations)

The course was discontinued by the university.

Examinations (2011-2013 Batch)

The examinations for students admitted to 2-Year MBLA were conducted in the month of June, 2013. Where **fifteen students appeared and all of them qualified** for the award of the Degree. The 2-Year MBLA Degrees were awarded to the successful students at the Annual Convocation held on July 27, 2013.

M.Phil. and Ph.D. Degree Programmes

Admissions

The University had received three applications for admission to M.Phil. and 52 applications for admission to Ph.D. Programme during the period under report. Out of the total of 52 candidates, 21 candidates had qualified UGC NET / JRF, hence, they were exempted from taking the Admission Test. The university had conducted admission test for admission to M.Phil. and Ph.D. Degree Programmes on August 18, 2013. Three candidates for M.Phil. and 31 candidates for Ph.D. were required to take the admission test whereas one candidate for M.Phil. and 26 candidates for Ph.D. had appeared for the said test. Only 14 candidates had qualified in the said test for admission to Ph.D. and none to M.Phil.

35 candidates including 21 candidates who were exempted from taking the admission test were asked by the university to submit their preliminary proposals and to make a presentation before the Research Committee. 29 candidates made presentations before the Research Committee out of which 14 candidates could qualify and were offered provisions admission to Ph.D. degree programme. Hence, all 14 candidates were registered to the Ph.D. degree programme including five women.

Ph.D. Thesis Submitted

Five scholars submitted their Ph.D. Thesis and they qualified for the award of Ph.D. Degree, during the period under report. Ph. D. Degrees were awarded to the successful scholars at the annual convocation held on July 27, 2013. **This was the highest number of Ph.D. Degrees awarded in the history of NALSAR.**

LAUNCH OF INNOVATIVE COURSES

NALSAR has already established its name in producing law graduates of highest quality and the integration of management studies with law was yet another milestone in carrying forward its reputation of being an innovative academic leader. This year the University launched a **unique M.B.A. program with four major specializations and three minor specialisations** through its Centre for Management Studies. The objective of the programme is to produce graduates with necessary managerial skills and requisite legal acumen.

The course was launched in response to the need felt by the Indian judiciary to get competent professionals to improve the efficiency of our judicial system. Some High Courts have already started appointing M.B.A. graduates to manage the judicial system. Judicial Management is the latest field in the

discipline of management. No business school in India presently offers court management as a specialization in its M.B.A. program. NALSAR is going to fill the vacuum and certainly it is best suited to do so.

There can be no denial of the fact that the knowledge of basic principles of business laws is necessary in today's corporate world to carry out business transactions within and outside the country. The M.B.A. program, having the integration of management and law at NALSAR caters to the needs of the business world today. NALSAR's M.B.A. indeed creates new synergies by integrating management with law.

NALSAR has also started **innovative 'online-onsite' courses** such as **Master's Degree in Aviation Law and Air Transport Management; Master's Degree in Space and Telecommunication Laws; One-year PG Diplomas in: Aviation Law and Air Transport Management; GIS and Remote Sensing Laws** under the aegis of Centre for Air & Space Law. The unprecedented growth in aviation sector coupled with the commercialization of space technologies has created the need for thousands of skilled manpower to meet the requirements of rapidly growing aerospace and telecommunications sectors. In view of 2G controversy, there is an urgent need to have specialisation in the upcoming discipline of telecommunication laws.

As per the decision of the Academic Council and the Executive Council of the University the admission procedure, course outlines and the evaluation procedures were reviewed by an expert Committee consisting of the eminent subject experts in the relevant field. **Accordingly Academic and Examination Regulations were prepared and the same were approved by the Academic Council and Executive Council.**

Admissions

10. RECRUITMENTS / JOB PLACEMENTS / INTERNSHIP PLACEMENTS

Recruitments / Job Placements

The graduating students enjoyed an outstanding placement record. International and National Law Firms, Corporates, PSUs and Government Agencies came for Campus recruitments with highly attractive pay packages.

The students of eleventh batch were placed with national / international Law Firms, Banks, Corporates. Out of 80 students, seven students were taken as Judicial Clerks by the Hon'ble Judges of the Supreme Court of India, whereas six students entered the Bar, seven students were recruited by Foreign Law Firms, 52 students were recruited by domestic corporates and Law Firms, eight students have taken admission for higher studies at Oxford University, Cambridge University, London School of Economics and UCLA. Though the pay packages offered by domestic law firms range from Rs. 7 lakhs to Rs. 15.5 lakhs p.a. and by foreign law firms Rs. 32 lakhs p.a. Job placement for all graduates who opted for it have been 100% yet **20 students took up litigation as a career which is highest number in the University's history. One of the NALSAR Alumnus topped the Haryana Judicial Services Examination and another got second position in the Delhi Judicial Services Examination.**

NALSAR believes that learning is not only done in classroom alone but also at place of work. To give practical insight, the University has systematic student run winter and summer internship programmes.

The students of the B.A., LL.B. (Hons.) and LL.M. Degree Courses went for internships with government and non-governmental organisations, national and International Legal Corporates, Senior Lawyers and Law Firms. Some students worked as internees (Law Clerks) with the Hon'ble Judges of the Supreme Court and High Courts. Internship Placement is made keeping in view the preferences and aptitudes of the students in terms of what sort of employment they look for. Orientation training is given to the students to prepare them for placement with different organizations and the type of work which they are supposed to do as internees. After the internship is over, the students submit their reports to the University and these reports are taken into account for next internships.
