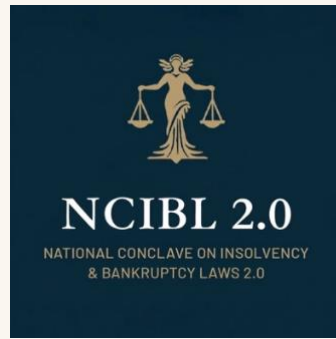

ABOUT THE COMPETITION

The CIRP Simulation Competition is a pioneering student-driven initiative in Insolvency and Bankruptcy Laws, hosted by the LL.M.-IBL Batch of 2025–27 at NALSAR, Hyderabad in collaboration with IICA, Delhi.

The competition simulates the full lifecycle of a Corporate Insolvency Resolution Process, demanding statutory precision, strategic acumen, and persuasive advocacy before simulated NCLT and Committee of Creditors (CoC) panels. India's insolvency ecosystem is rapidly expanding yet faces a critical shortage of bankruptcy professionals. This competition offers students from law, finance, management, and economics a platform for meaningful engagement with real-world CIRP practice.

TEAM STRUCTURE

Each team of two members shall assume distinct, fixed roles mirroring key participants in an actual CIRP proceeding. Participants must strictly adhere to the responsibilities and limitations of their assigned role throughout all rounds.

COMPETITION STRUCTURE

STAGE I — ONLINE

RESOLUTION PLAN SUBMISSION

- > Mandatory Submission Resolution Plan prior to on-campus rounds
- > Dossier at discretion
- > Evaluated on CIRP sequencing, compliance & analytical clarity
- > Must comply with IBC and CIRP Regulations

STAGE II — DAY I · 11TH APRIL

QUALIFIER ROUNDS

- > Inaugural Session & orientation
- > Qualifier Rounds before judges as Committee of Creditors
- > Semi-Finalists announced by end of day

STAGE III — DAY II · 12TH APRIL

SEMI-FINALS & FINAL ROUNDS

- > Semi-Final Rounds
- > Final Round before a simulated NCLT Bench
- > Valedictory Ceremony & Prize Distribution

WHO CAN APPLY ELIGIBILITY CRITERIA

- § Students pursuing a full-time 3-year or 5-year LL.B. from a university recognised by the Bar Council of India or relevant statutory authority.
- § Students enrolled in LL.M. programmes from recognised universities duly accredited by the UGC.
- § Undergraduate or Postgraduate students in Finance, Management, Economics, or allied disciplines from recognised universities.

Each team must consist of exactly two (2) members from the same institution. Cross-institutional teams are permitted.
