Electricity is a universal necessity and has become indispensable be it for domestic use or commercial and industrial applications. The proposed course on Indian Electricity Law aims to familiarize the participants with law, policy and regulatory framework governing the electricity sector. This interdisciplinary course blends ASCI's expertise in technical and policy aspects and NALSAR's domain knowledge in legal and regulatory aspects.

CONDUCT OF THE COURSE

Sessions will be conducted by academicians, professionals and industry experts during weekend, i.e., on Saturdays and Sundays. The online sessions will be conducted in live mode only and all the registered candidates are required to join the same without fail.

Soft copy of the reference materials will be provided to the candidates. The material may include legal texts, landmark judgments, case studies and regulatory orders.

If the enrollments exceed 100 candidates, then the University may conduct the classes in different batches on different dates.

MODE OF ASSESSMENT

Online Examination will be conducted only once at the end of the course. The assessment may include MCQ and problem/ case study-based questions.

AWARD OF CERTIFICATE:

- **Course Completion Certificate:** Candidates securing 50% or more in the Assessment Test will be awarded the '**Course Completion Certificate**'
- **Certificate of Participation:** Candidates who fail to attend the assessment test and / or fail to secure 50% score in the test will be awarded '**Certificate of Participation**' subject to them attending at least 75% of the sessions.

Steps to fill the online application form:

STEP1: The candidate should register by providing the email id and other details on the registration page. After completion of the registration, the login details will be sent to the registered email id.

STEP2: The candidate should login using the login id and password.

STEP3: For complete details, kindly go through the course brochure, which is available on the Registration Page and the Website and proceed for filling the application form.

STEP4: Fill all the details in the application form. All fields (with *) shall be filled compulsorily. Upload all the documents and the photograph as listed in the application form.

STEP5: After filling all the details PRESS 'SAVE' to save the data entered by you. Candidates can login and keep entering / modifying the data till payment is done.

STEP6: After filling all the details, the next step is to make the payment. Make the payment using the Online payment gateway.

STEP7: If your payment transaction is successful, the fee receipt will be generated and the same along with the filled-in application form will be available on the DASHBOARD. If the payment transaction is failed then you need to do the payment process again till your transaction is successful.

Mandatory Documents to be uploaded with the application form:

1. Copy of the marks statement / Passing Certificate of X Standard (SSC) or equivalent. The name as appearing in the X Standard (SSC) or equivalent Certificate will be used by the University for all purposes including for the award of Certificate by the University.

2. Copy of the Degree Certificate / Provisional Degree (i.e., an examination equivalent to Graduation). **Candidates pursuing Graduation should submit the previous year mark sheet or bonafide certificate from the college.**
3. Passport size photograph.
